It stands against monopoly in such areas as pedigreed canine breeding, organized hunt assisted with dogs and all sports with dogs, and also for mutual recognition and honor between all cynological organizations around the world, and for equality in their work. Members of WCHSA can be organizations (officially registered) with different size and activities range; the membership in WCHSA is voluntary and does not require payments of any affiliation or membership fees.

The WCHSA membership may be full or limited (associated), as stated in the concomitant Membership Regulations.

III. OBLIGATIONS IND RIGHTS OF WCHSA

With this contract WCHSA takes the oulgations to, on its account: carry out both overall and personal information and publishing services for all members – full and limited; to ensure the year-round function of the main office (excluding 1 month holidays) and to fulfill the contacts between the members and the central office in time and without slowdowns; to coordinate the work of all members in the fields of work concerning the goals and aims of WCHSA in the departments under control of the central office and the other organs of WCHSA; to serve in time and in timely manner the service of the physical persons and the regional offices of all the members (both full and limited); to organize not less than two times early Congresses of WCHSA and on its account to provide the data service and materials for the Congresses; to keep confidentiality concerning the information about WCHSA as whole and its members.

WCHSA has the right to access information connected to the work of the member organizations concerning the effective control and coordination of the European directives and international laws (in particular – animal welfare as whole, the zootechnical parameters of the breeding programs, sports with dogs and practical use of the dogs in hunting) and also control and

IV. OBLICATIONS AND RIGHTS

With the signing of the long at the VEW MEMBER n a period of maximum 3/6/12 months to put its rules, regulations and documentation in conformity with the requirements of WCHSA and after that it is obliged to work in accordance to the rules and regulations of the organization. The NEW MEMBER is obliged to give to the main office in time all the information required about its work and activities, the past events of national and regional level, past and future events of international level, and also submit in time all kennel name applications, international and multi-championship forms, confirmation forms for judges and trainers categorization, expositions and events calendars. The NEW MEMBER is also obliged to keep active at least one web-based service (web-site, Facebook page or account, other) about the organization and one e-mail account. It is obliged also to keep confidentiality concerning the internal information about WCHSA and the other members; to assure full assistance for fulfillment of activities and reaching the goals of WCHSA and to fulfill the decisions of the Congresses, the meetings, the regional coordinator, the commissions and the other authorized organs and persons; to give to WCHSA all the information needed for the normal functions of the main office. The NEW MEMBER is obliged to recognize the breed standards, documents

V. SIN WCIAL OBLIGATIONS

As per decision of WCHSA Congress from 2018, sins 291.01/2019 the following financial-obligations are in effect:

- 50 Euro per year to the web-tosting and design of the website of WCHSA
- 20 Euro per each internal onal deg show (CACIB) to the expenses of the central office.
- 50 Euro license per year for all International judges
- 35 Euro for international registration of a Kennel name
- 15 Euro price for an International champion, Multichampion, Grand International and Grand Multichampion certificates (which are to be issued by the central office only)

Also at the Congess 2019 it was decided that:

- When holding a championship of another country, the organizing organization is to keep 100% of the champion certificates exchange price.
- Each International rank expert is to receive "souvenir money" per each show judges amounting to 50 Euro and has no right to ask for a bigger amount; the inviting organization is obligated to take care of all the expenses of the judge in connection with

Termination of the contract may be made by:

- Mutual agreement. The NEW MEMBER states decision to leave WCHSA at a Congress or Working meeting.
- B. Unilaterally. The NEW MEMBER announces in written form to WCHSA (the main office) its decision to terminate the contract or, after a proposal stated from the main office is seen at a Congress/Working meeting, the main office announces in written form to the member to inform it about the termination.
